Use Overview:

Good Sense® Odor Eliminator utilizes non-pathogenic bacteria and the enzymes they produce to help remove foul odors caused by urine, feces, blood, vomit, food spills, garbage and grease. It also helps remove odors from drains, while also helping to prevent clogging of drains. For use on all washable surfaces.

Do not use with hot water, bleach, disinfectants or chemical drain openers as these will reduce product performance.

Odor Control

- Control odor for restrooms, dumpsters, kennels, healthcare, restaurants, schools and prisons.
- Do not spray into air or use as an air freshener.
- Remove solid waste before applying.
- Dilute 1:1 to 1:10 (128 oz. to 12 oz./gal. [3.78 L to 355 mL/3.78 L] warm water) and apply with trigger sprayer, sponge, mop or cloth.
- This product must contact surface to be effective.



Drain Lines/Down Pipes/Plumbing

- Prevents clogging of restroom, kitchen and mop sinks, floor and laundry drains, toilets and urinals, dishwashers and garbage disposals.
- Use 8 oz. (236 mL) of diluted product (1:10) for every 2 inch (5 cm) inside diameter of pipe two to four times a week.
- For best results, treat at the end of the day or when flow is lowest.
